**WHEREAS,** the District is seeking to obtain a facility hardship review and approval and a facility hardship funding approval by the State Allocation Board for San Marcos High School; and

**WHEREAS,** the statements set forth in the facility hardship forms, supporting documents and subsequent funding forms are true and correct to the best of our knowledge and belief.

NOW, THEREFORE, THE BOARD OF EDUCATIONOF THE SANTA BARBARA UNIFIED SCHOOL DISTRICT DOES HEREBY RESOLVE, DETERMINE, AND ODRER AS FOLLOWS: that the District Superintendent, the District Assistant Superintendent for Business Services and the District Director of Facilities and Operations are hereby designated as District Representatives who are authorized and directed to execute and file applications and supporting documents for San Marcos High School facility hardship determination and facility hardship funding from the State Schools Facilities Program under Chapter 12.5, Part 10, Division 1, commencing with Section 17070.10 et. Seq. of the California Education Code.
