- 1) Remove six urinals. Cap off the waste and water piping.
- 2) Set up a containment area to allow for the safe removal of the existing wall finishes. Remove the tile and mortar bed to expose the existing piping. Clean up the work area and transport the debris to the recycle center.
- 3) Remove the deteriorated cast iron waste and vent piping. Provide and install new waste and vent piping using no-hub cast iron pipe and fittings. Test and inspect the new piping.
- 4) Provide and install the electrical system to operate the electronic flush valves.
- 5) Provide and install water proofing for the wall as well as the lathing and mortar bed. Set and grout the tile, matching the existing tile color and pattern.
