THE FOLLOWING IS OUR SCOPE OF WORK ON THE PROJECT, WE WILL NOT TELEPHONE OUR BID TO YOUR OFFICE.

**JOB LOCATION:** 

Goleta Valley Junior High School, 6100 Stow Canyon Road, Goleta, CA

**SCOPE OF WORK:** Provide and install a two way cleanout to remove the obstruction in the waste line. Hydrojet the waste piping from the grease interceptor to the 6" inch main sewer line to clean and remove the grease from the piping.

## PROCEDURE:

- 1) Set up temporary fencing around the work area.
- 2) Saw cut, break and remove a section of concrete walkway to access the waste piping.
- 3) Excavate a trench 7'-0" deep to expose the waste piping. Provide and place trench shoring.
- 4) Provide and install the piping modifications to the waste line. Clean the waste piping using a hydrojetter to remove the grease from the waste piping.
- 5) Backfill the pipe zone with sand. Complete the backfilling and compaction using the native material.
- 6) Drill and rebar dowel the edges of the concrete patch. Provide and place the rebar.
- 7) Provide and place traffic rated cleanout boxes over the cleanouts for future access.
- 8) Pour and finish the concrete patch. Remove the temporary fencing and clean up the work area. Transport any construction debris to the recycle center. \$16,500.00
