! am writing to bring to your attention irregularities in the bid proposal submitted by Western Group Inc for the above referenced project. Western is the apparent low bidder as indicated on the bid tabulation sheet published yesterday by the District. Based upon review of Western's proposal, Western Group cannot meet the requirements of the bid documents and project specifications.

Public Contracts Code §4106 states that if a prime contractor fails to specify a subcontractor when so required, the prime contractor agrees that he or she is <u>fully qualified</u> to perform that portion himself or herself and will in fact perform that portion of the work. We believe that the Western Group does not possess the appropriate license to perform major parts of the work where no subcontractor was listed on the Western Proposal, and as such have been given an unfair bidding advantage. It appears Western currently possesses an A General Engineering, B General Building, and C10 electrical license. Western did not list subcontractors for the following trades and does not possess the pertinent license of each trade nor are they know to self-perform this work: Plaster C35, Ceramic Tile C54, Plumbing C-36, Sheet Metal C43, Asphalt C-12 and Painting C33, Fencing C13, Framing C5, Skylights. These trades all easily exceed the ½ of 1% listing requirement for subcontractors and as such these trades should have been listed and are now available to price shop upon award of the project.

We would object to awarding the project to Western based on Westerns bid being non-responsive in that not listing its subcontractors it acts to circumvent the subcontractor listing laws which affords them an unfair competitive advantage.

Based on the aforementioned we believe McGillivray is the lowest responsive bidder and therefore should be awarded the project and are fully prepared to execute your project in a timely manner.
