Ms. Carey introduced students from Dos Pueblos High School who presented the student report.

Sunny Graybill, ASB President; Will Caird, ASB Representative; and Lindsey Fischer, Social Media Commissioner presented to the board the need to have a schedule that allows them to take more electives and courses of choice throughout the year. They showed their current class schedule which they said does not allow them enough opportunities to expand their interests and students feel a lot of stress due to it being academically heavy with no opportunities for enrichment or electives. They went on to say that their desire is to have access to more electives, create more well-rounded students and learn new skills. They would also like to create more elective opportunities in Special Education, Advancement Via Individual Determination (AVID), Dos Pueblos Engineering Academy (DPEA), English Learners, and Athletes. Provide options for higher-level/dual enrollment elective classes as incentive for hard working students, and create more CTE pathway opportunities.

 Financial Report for the Period Ending June 30, 2018 and the Required

Ms. Jette introduced Ms. Shyloh who presented the audit report.

Ms. Shyloh reported that the financial statement as well as the control report are both a clean reports. She went on to say that there was one finding to the instructional materials, which was the timing was not met, however, there was no fiscal impact. She also said that page 87 gives an opportunity to look at the last 3 years, the reserves are being met. Prop 39, financial audit and the performance audit are also all clean, no findings on compliance.

2. Report Regarding Dual Language Immersion in Santa Barbara Unified 30 Minutes (Ramirez/Larios-Horton)

Dr. Ramirez presented this report. He acknowledged that as the district continues to strive forward in building from the assets and culture that our students and families bring on a daily basis, it is an important next step for the district. He went on to say that tonight's report builds on the legacy within the community of Adelante Charter formerly Cesar Chavez. He also highlighted the importance of the District English Learner Advisory Committee (DELAC) in their participation and leadership. The board had a discussion.

3. Mission, Vision, Core Values – for Santa Barbara Unified School District 15 Minutes (Matsuoka)

Superintendent Matsuoka shared that this mission statement has been field tested in a lot of settings like at the opening school rally and the State of the District. The feedback he has received has been that it makes sense and it also guides the work of the district. He explained that the vision statement is more tactical, it is the nuts and bolts of what we are doing and leading in our schools and it aligns with college career readiness. The board

had a discussion and made some language change recommendations.
