Superintendent Matsuoka reported that Santa Barbara High School student Arhlenny Wendy Hernandez passed away last week after a long illness. Mr. Matsuoka asked for a moment of silence in her honor.

Mr. Matsuoka also reported that interviews for the Principal at San Marcos High School were held today. He said it was a very extensive process with 35 people on the panel composed of staff and parents. The recommendation was unanimous to move forward. He went on to say that the reason for accelerating the process is that the candidates are applying for other positions at other districts and does not want to loose the top candidate.
