Demographic and Income Report for SBUSD in the Context of Santa Barbara

Background

We have received much public comment about our test scores, our schools, literacy, etc. over the last six months. We wanted to provide some context about our demographics, emerging multilingual learners (aka, English Language Learners), socioeconomically disadvantaged students, and comparative financial data.

SBUSD is 60% Latino. Our nine elementary schools are 73% Latino. Our seven Title I schools (Adams, Cleveland, Franklin, Harding, McKinley, Monroe, SB Community Academy) are 86% Latino.

Multilingual Learners (EL) in Santa Barbara

As we develop our Comprehensive Plan for MultiLingual Pathways (CPMP), we wanted to highlight some data about our English Language Learners in Santa Barbara. Here are some definitions that comprise the broad landscape of students who arrive to our district with a primary language other than English.

IFEP – a student for whom a language other than English is reported on a Home Language Survey, and is deemed proficient in English

EL – a student for whom there is a report of a language other than English on Home Language Survey, and needs to develop the English language skills of listening, speaking, reading, and/or writing necessary to succeed in the school's regular instructional program

RFEP – a student who is reclassified as proficient in English, using an assessment of English proficiency in listening, speaking, reading, and writing as measured by multiple measures

The term "ever-EL" applies to a student who at one point in their K-12 experience was IFEP, EL, or RFEP. Another way of describing such a student, their first language at home was other than English.

Socio-Economically Disadvantaged (SED) Students in Santa Barbara

The CDE definition of Socio-Economically Disadvantaged students includes students who met a least one of the following seven criteria:

- 1. neither of the student's parents has received a high school diploma
- 2. the student is eligible for or participating in the Free Meal program or Reduced-Price Meal program
- 3. the student is eligible for or participating in the Title I Part C Migrant program
- 4. the student was considered Homeless
- 5. the student was Foster Program Eligible
- 6. the student was Directly Certified
- 7. the student was enrolled in Juvenile Court School

We have included data for the five public districts in Santa Barbara as well as other nearby districts that the reader might be familiar with.

Our Socio-Economically Disadvantaged data has SBUSD as similar to districts such as Ventura, Carpinteria and our SBUSD Elementary schools are similar to districts such as Long Beach, and Lompoc. The perception of Santa Barbara Unified is that we are a wealthy district with little poverty. The reality in our schools, especially our elementary schools are neighborhoods with deep socio-economic challenges.

Financial Income Data

The last category of data before we make some conclusions is the financial income data per ADA for our five public school districts and the same set of other comparison districts used in the SED section above. The statewide average for K-12 districts is \$12,714. We are 1% above that average, \$12,747.

We highlight some important comparison districts:

Santa Monica-Malibu gets \$16,466 (29.2%) more per student

Goleta Union gets \$2,265 (17.8%) more per student Carpinteria gets \$1,285 (10%) more per student We are funded in same range as Oxnard High (+\$247 more), Santa Maria Bonita (-\$176 less), Oxnard Elem (-\$245 less), and Lompoc (-\$480 less)

Santa Barbara Unified is perceived as a wealthy district due to our geographical setting and being surrounded by high income partner districts. We are not a wealthy school district.

Summary

In summary, here are three important realities that exists in Santa Barbara Unified School District.

- 1. We are a Latino dominant school district, especially in our elementary schools.
- 2. Our socio-economic disadvantaged profile, especially our elementary school, is more like districts in north SB County or in Ventura County.
- 3. Our income is right at the state average we are not a high wealth district.
