5. Superintendent's Report - The superintendent and/or his designee may report about various matters involving the districts. > Superintendent Matsuoka introduced Ms. Jennifer Balaishis, Coordinator of School Climate and Safety. He said Ms. Balaishis was the Dean of Students at San Marcos High School and has a counselor by background and she is trilingual and will be able to communicate with different audiences. He thanked the Principals for all the work they put in to organizing graduation ceremonies that they could create during these conditions. Mr. Matsuoka said that the Pledge of Allegiance is part of the culture of our Country, but today those words are a call to action, "Do we really have liberty and specially justice for all?". He went on to say that the dead of George Floyd is one of many moments in our Nation's history about the injustice to an individual. He let the community know that the district has been working hard, the board approved the Multilingual Pathway plan a few meetings ago to ensure that every language and culture is respected and appreciated in our district. The student call for Ethnic Studies courses was also approved, and tonight, the district is presenting two more courses that will fulfill those graduation requirements. As far as equity work, the district has had a decade long relationship with Just Communities which has brought so many resources, programing capacity, talking in class, the work with staff around the IEE, and the work with families. In the last three years, the focus has been in Implicit Bias training which over 500 staff have participated in. Mr. Matsuoka said that we stand with the community to become a better society at least in Santa Barbara.

6. Board Comments and Correspondence

President Capps reached out to the student organizers of the peaceful protest and invited Talia Hamilton to give her comments.

Talia said that the idea of the peaceful march was because a lot of the marches that were being held were adult organized, and it is important to hear the raising generation. She talked about the demands they are asking the school district. Those include; Ethnic studies classes, allocate funds to rehabilitation and mental health services for at-risk youth as an alternative for probation and juvenile hall, to defund any contracts with Santa Barbara County Sheriff's department and the Santa Barbara Police department, condemn the school to prison pipeline, implement equitable hiring practices and recruit culturally competent teachers of color to teach Ethnic studies courses, Adopt a resolution declaring racism as a public health emergency and allocate resources to implement restorative justice practices to deal with hate crimes, and include students in decision making.

Board members were able to attend graduation celebrations that were put together by the principals.
