# FILE IMPORT INTEGRATIONS

It is our priority to ensure data privacy and security requirements are maintained for data source integrations that do not support the Ed-Fi API. To support this, regardless of the integration style of file imports, it is the responsibility of the customer to upload these files to our FTP/S server. Files are processed automatically once uploaded.

Certica contributes to the on-going development of the Ed-Fi Data Import Tool, which is provided by the Ed-Fi Alliance and may be installed locally by the customer at no cost. Certica will issue API credentials for the customer to connect the Data Import Tool to the Ed-Fi API. Certica recommends professional services assistance with defining data mappings while using the Data Import Tool unless the customer has pre-existing experience with Ed-Fi.

# TRAIN-THE-TRAINER SESSION AND ROLLOUT PLANNING

A Videri application specialist will work with your district to design a roll-out plan and visit your district for a one-day "train-the-trainer" session for up to 15 people. (As of July 2020, Certica is conducting all sessions virtually.)

All provisioning and ongoing application support services are included in the Videri license fee and a one-time, fixed provisioning fee. Districts should be prepared to complete provisioning tasks including SIS-to-dashboard code mapping, data sync and dashboard validations. Certica staff will be available to provide virtual support throughout these processes. Depending on the number and variety of data areas and use cases, Videri provisioning is usually accomplished in an elapsed time period of 4 to 10 weeks.
