Mr. Matsuoka briefly went over the framework that he is putting into place. It is broken into a low impact, moderate impact, and high impact incidents and it includes the communication vehicles that they will use to get the word out as well as guidance about how the district needs to handle each situation. As for the School Resource Officer, Mr. Matsuoka said that it is something that they will have to debate as a school and community. He went on to say that the district has the direct support of Just Communities and the Anti-Defamation League.

Mr. Matsuoka deployed a team of tech coaches to start educating students about how to be a citizen in cyber space. He also said that a tool called STOPit! for anyone to report something that they are concerned about, it is an anonymous tool and it gets to all levels of leadership so that they know what is going on.
